#### An Electric Car in Your Future?

Some environmentalists predict that today's middle school students will someday sit behind the wheels of electric cars. I say, "Don't count on it!" Electric cars will not be the practical answer to the problem of pollution caused by cars.

Electric cars have just too many problems. They are powered by batteries, but the batteries hold only enough power to drive about one hundred miles. After that short distance, the battery has to be recharged for three hours. Another problem is that electric cars do not have the same power to climb hills and accelerate that gasoline-powered cars do. Imagine chugging along, straining to get up hills, and worrying about whether you have enough power left to get where you are going. This is not carefree driving. The situation's not likely to improve in the future. According to Art MacCarley, professor of electrical engineering, "It is doubtful that electric cars will ever enjoy the range or performance advantages to which auto users have become accustomed with petroleum-fueled engines." I simply do not think people will be willing to put up with slower, less powerful cars for the sake of the environment.


Are electric cars as good for the environment as some would have us believe? These so-called zero-emission vehicles are supposed to reduce or eliminate harmful emissions into the air. Researcher Michael Quanlu Wang believes that the cars, in fact, may do a different kind of damage to the atmosphere. He admits that use of electric cars would reduce several kinds of pollution. Wang points out, however, that emissions of sulfur oxide would actually increase with widespread use of electric cars. Sulfur oxide is a major cause of acid rain. In other words, choose your poison!

Another reason to question the use of electric cars as a solution to air pollution is concern about lead. Most electric cars are powered by lead-acid batteries. One study shows that electric cars release sixty times more lead into the air than gasoline-powered cars do. Lead can cause serious problems in the human nervous system, especially in those of young children. This is the reason leaded gasoline is no longer sold. This problem is not likely to be solved simply by using a different kind of battery, because the alternatives are expensive.

While some may be enthusiastic about the future of electric cars, I predict these cars will go the way of the dinosaur. They cannot compete in our fast-paced world. In addition, they pose risks for the health of young children and others. I believe we need to put our efforts into finding other, more practical, and yes, more environmentally friendly means of transportation for the future.
